

Welton Cemetery Meeting Minutes

January 20, 2016

Ms. Kimpton called the meeting to order at 10:26 AM

Roll Call: Marcianne Kimpton - present, Arleen Richardson - present, Newell Beaumier - absent

Council Representative: Roberta Dobay – present

Visitors: Lenore Pikus

Clerks Report:

Ms. Kimpton made a motion to accept the minutes of October 28, 2015, Ms. Richardson seconded. By voice all agreed.

Discussion:

Ms. Kimpton explained to Ms. Dobay the burial and disinterment of Karen Riddell. Ms. Riddell was moved from G36 to G34 due to a family matter. The Board asked that all Heirs to that lot and Mrs. Lillibridge, the holder of the deed sign off that she could be buried in G34. Papers were received and the disinterment and the re-burial took place on October 30, 2015. The legal fees with Thrasher, Dinsmore and Dolan cost approximately \$2,000.00 for this case to be settled through our board and the family paid for the disinterment and the re-burial, total cost \$630.00.

Unfinished Business:

Ms. Kimpton asked Ms. Pikus to get an estimate from Ronyak Bros., Burton Scot and Cunningham Paving for the proposed exit on the east side of the Welton Cemetery.

New Business:

Ms. Dobay offered to check with Urban Growers for flowers for this upcoming spring/summer season for the cemetery. She will use the baskets we currently have available. She will also talk with Chief Smigelski to see if we can ask the street department when watering the baskets hanging throughout the village that possibly they can water the 18 urns at the cemetery. Ms. Kimpton will check to see the availability and condition of old urns that may be in storage and in need of repair.

Ms. Kimpton stated that she would like to organize the deed book, map of the cemetery and the cemetery itself in section order for easy access. Ms. Pikus, Ms. Richardson, Ms. Dobay and Ms. Kimpton agreed that this would be a good project for 2016. After the deeds are physically compared to the cemetery the map will then be updated by Hess and Associates and the deed books will be in section order. The computer data will remain in excel for record keeping.

Ms. Dobay and the board asked Ms. Pikus to gather information regarding the Burial, Foundation and Lot fees from Newbury Twp., Claridon Twp. and Munson Twp.

Ms. Pikus reported that pricing from Mr. Owen Gingerich for burials and Mr. Szuszkiewicz for foundations will remain the same as 2015.

Ms. Kimpton moved to adjourn and Ms. Richardson seconded. The meeting adjourned at 11:10 AM.
