Mayors Report

Standing Committees

Finance, Funding and Personnel Committee – Mr. Boehnlein & Mr. Ferroni met to discuss the handbook changes.

Police Department Report – Chief Smigelski stated the Police Department responded to 88 calls, there were 7 traffic citations and 3 arrests made in the month of May.

Fire Department Report – No one was available to report.

Street Committee – Chief Smigelski stated the garbage cans and the dog waste station were installed in the park.

A pre-construction meeting was held for the Goodwin Improvements Project. Work will begin this week.

Council Reports on Independent Boards and Commissions

Board of Public Affairs – Mr. Hansel stated the new WWTP should begin operation in June 30th and final grading will be complete by the end of July. BPA approved the request to reallocate the \$18,000 for RPR expenses to ARCADIS as Council approved at the previous meeting and approved the installation of an electric line to the WWTP generator from the water plant in case there is a power outage. Utility shut offs will resume in July.

Board of Zoning Appeals – Mr. Blair had nothing to report.

Cemetery Board – Ms. Richards had nothing to report.

Historic District Architectural Review Board – Mr. Brown had nothing to report.

Planning Commission – Mr. Blair said a meeting will be scheduled for rezoning a piece of Preston Superstore and Demko property, and to approve two lot splits.

Tree Commission – Ms. Palmisano stated she confirmed that Mr. Nelson removed the trees in front of his home. Ms. Palmisano requested an additional penalty be charged to Mr. Nelson in addition to the restitution of the trees and related expenses. Mr. Hicks stated the penalty can only be charged by a Judge if we were to press charges. Being that Mr. Nelson is willing to pay the restitution, Council doesn't wish to pursue charges at this time.

Chamber of Commerce – Mr. Blair stated the Chamber is open and practicing social distancing guidelines.

Berkshire Community Planning Association – Mr. Brown stated BCPA met to discuss the future zoning for the school properties such as the High School, Elementary School, practice fields across from the Fairgrounds, and Ledgemont properties and will be meeting again soon to talk to the community about these properties.

Burton Historic District Association – Mr. Brown had nothing to report.

Fiscal Officers Report

Ms. Dahlhausen said a second meeting will be needed in July after the first pay request for the Goodwin Improvements Project arrives. When received, she will contact Council to schedule a special meeting.
