## **Ordinances and Resolutions**

Mayor Spanos placed on second reading, Ordinance 2391-20 amending sections 1109.01 and 1135.03 of the Burton Village Planning and Zoning Code. A public hearing will be held on January 25<sup>th</sup> at 7 PM.

Mayor Spanos placed on first reading, Ordinance 2394-21 authorizing the Mayor and Fiscal Officer to enter into an agreement with Geauga Cable Access Corporation to provide Local Cable Television Programming from January 1, 2021 through December 31, 2022.

Mr. Boehnlein reviewed a list of Cable Franchise Fee revenue from back to 2014, which has increased from about \$13,600 to about \$15,000. The revenue since 2014 is just over \$100,000. If this revenue wasn't paid to GTV as determined by the contract, the village could use it elsewhere. Mr. Boehnlein feels the school uses this service the most and there isn't much use for the village.

Mr. Blair feels that with COVID, this is used even more by elderly in the community to watch school games and would like to continue the contract. Mayor Spanos agreed.

Mr. Brown said he saw the school is providing the games live through Facebook now too.

Mr. Hansel said he feels this revenue could go toward a better use.
