New Business

Mayor Spanos stated Adam Miller has moved outside the village and resigned from his BPA position so there is an open seat. Council would like to interview interested candidates and appoint a member at their next meeting.

Chief Smigelski provided two quotes from Vance’s Law Enforcement; three rifles for \$3,028.53 and, a new taser and supplies for \$1,736.56. The current rifles are employee owned so Chief would like to purchase department owned guns and the taser needs updated.

Mr. Boehnlein moved to approve the quote from Vance's Law Enforcement for \$3,028.53 for three new rifles, seconded by Mr. Ferroni. By voice vote, the motion passed.

Mr. Boehnlein moved to approve the quote from Vance's Law Enforcement for \$1,736.56 for a new taser and supplies, seconded by Mr. Ferroni. By voice vote, the motion passed.

Public Participation

Mr. Tiber expressed concerns if the village decides to enforce a no parking ban on streets overnight. He has four people in his house and uses the road for additional parking often. Council discussed briefly and said they would consider his concerns. Mr. Hansel and Chief Smigelski informed residents about municipal parking around the village park, and stated if enforced residents could contact the Police Department if they were having an overnight guest that would need to use the street.

Mr. Boehnlein moved to adjourn, seconded by Ms. Richards. By voice vote the motion passed. Meeting adjourned at 7:24 PM.
