**New Business**

Mr. Ferroni had someone approach him about the mosquito issue in the village. He asked them to attend the April 25<sup>th</sup> meeting with some solutions.

Mr. Blair stated the Chamber of Commerce typically pays for the hanging baskets each year but they have agreed to pay for \$1,500 towards them this year and the fertilizer cost. Chief Smigelski mentioned there were some fertilizer issues the last few years and the hanging baskets died but they have everything figured out now. He will look into if we can still order them at this point and would like to limit displaying them to around the park and down Main Street. They were also placed down 168 and 87 in past years.
